## What is this product?

### Type

A spread bet ("SB") is a leveraged contract entered into with Spreadex on a bilateral basis. It allows an investor to speculate on rising or falling prices in an underlying index.

An investor has the choice to buy (or go "long") the SB to benefit from rising commodity prices; or to sell (or go "short") the SB to benefit from falling commodity prices. The price of the SB is derived from the price of the underlying commodity price, which may be either the current ("cash") price or a forward ("future") price. For instance, if an investor is long a crude oil SB, and the price of crude oil rises, the value of the SB will increase - at the end of the contract Spreadex will pay the difference between the closing value of the contract and the opening value of the contract. Conversely, if an investor is long and the cash price of crude oil falls the value of the SB will decrease - at the end of the contract they will pay Spreadex the difference between the closing value of the contract and the opening value of the contract. A SB referencing the underlying future price works in exactly the same way except that such contracts have a pre-defined expiry date – a date upon which the contract either automatically closes or must be rolled into the next period. The leverage embedded within all SBs has the effect of magnifying both profits and losses.

### Objectives

The objective of the SB is to allow an investor to gain leveraged exposure to the movement in the value of the underlying commodity (whether up or down), without actually needing to buy or sell the physical commodity. The exposure is leveraged since the SB only requires a small proportion of the notional value of the contract to be put down upfront as initial margin and is one of the key features of trading SBs. By way of example, if an investor buys a SB worth £1 per point with an initial margin amount of 10% and an underlying commodity price of 6000, the initial investment will be £600 (10% x 6000 x 1). The effect of leverage, in this case 10:1 (1 / 10%) has resulted in a notional value of the contract of £6000 (£600 x 10). This means that for each 1 point change in the price of the underlying commodity so the value of the SB changes by £1. For instance, if the investor is long and the market increases in value, a £1 profit will be made for every 1 point increase in that market. However if the market decreases in value, a £1 loss will be incurred for each point the market decreases in value. Conversely, if an investor holds a short position, a profit is made in line with any decreases in that market, and a loss for any increases in the market.

The cash SB does not have a pre-defined maturity date and is therefore open-ended; by contrast, a future SB has a pre-defined expiry date. As a result, there is no recommended holding period for either and it is down to the discretion of each individual investor to determine the most appropriate holding period based on their own individual trading strategy and objectives.


Failure to deposit additional funds in the case of negative price movement may result in the spread bet being auto-closed. Spreadex also retains the ability to unilaterally terminate any spread bet contract where it deems that the terms of the contract have been breached.

### Intended Retail Investor

SBs are intended for investors who have knowledge of, or experience with, leveraged products. Likely investors will understand how the prices of spread bets are derived and the key concepts of margin and leverage, and that losses may exceed deposits in a given position. They will understand the risk/reward profile of the product compared to traditional share dealing, and desire short-term, high-risk exposure to an underlying asset. Investors will also have appropriate financial means, hold other investment types and have the ability to bear losses in excess of the initial amount invested.

## What are the risks and what could I get in return?

### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance of the product at a very high level.

Spread bets are leveraged products that, due to underlying market movement, can generate losses rapidly. Losses can exceed the amount invested in a given position and you may be required to deposit additional funds in order to maintain your positions. There is no capital protection against market risk, credit risk or liquidity risk. **It is possible to lose the total balance on your account.**

**Be aware of currency risk.** It is possible to buy or sell SBs on a commodity in a currency which is different to the base currency of your account. The final return you may get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Market conditions may mean that your SB trade on a commodity is closed at a less favourable price, which could significantly impact how much you get back. We may close your open SB if you do not maintain the minimum margin that is required, if you are in debt to the company, or if you contravene market regulations. This process may be automated.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see the section "what happens if we are unable to pay you"). The indicator shown above does not consider this protection.

### Performance Information

A spread bet is a leveraged financial derivative that follows the price of an underlying financial market. A spread bet will make gains or incur losses as a result of price movements in the underlying asset. A spread bet will be quoted with a buy price and a sell price, with the difference being the spread fee. Spreads will affect the returns of your investment. The price of a Spread bet may be affected by factors such as inflation, interest rates, geopolitical events, government policy and economic factors.

### What happens if Spreadex Limited is unable to pay out?

If Spreadex is unable to meet its financial obligations to you, you may lose the value of your investment. However Spreadex segregates all retail client funds from its own money in accordance with the UK FCA's Client Asset rules. Spreadex also participates in the UK's Financial Services Compensation Scheme (FSCS) which covers eligible investments up to £85,000 per person, per firm. ## What are the costs?

Trading a SB on an underlying commodity incurs the following costs:

<b>This table shows the different types of cost categories and their meaning</b>			
<b>Cash and Futures</b>	<b>One-off entry or exit costs</b>	<b>Spread</b>	The difference between the buy price and the sell price is called the spread. This cost is realised each time you open and close a trade.
		<b>Currency conversion</b>	Any cash, realised profit and losses, adjustments, fees and charges that are denominated in a currency other than the base currency of your account, will be converted to the base currency of your account and a currency conversion fee will be charged to your account.
<b>Cash only</b>	<b>Ongoing costs</b>	<b>Daily holding cost</b>	A fee is charged to your account for each night your position is held. This means the longer you hold a position, the more it costs.
<b>Cash and Futures</b>	<b>Incidental costs</b>	<b>Distributor fee</b>	We may from time to time share a proportion of our spread, commissions and other account fees with other persons including a distributor that may have introduced you.
<b>Futures Only</b>	<b>Other Costs</b>	<b>Rollover costs</b>	We charge you to roll over a futures contract into the next month or quarter, equal to half the applicable spread to open and close a trade.

## How long should I hold a spread bet on a commodity, and can I take out my money early?

SBs are intended for short term trading, in some cases intraday and are generally not suitable for long term investments. There is no recommended holding period, no cancellation period and therefore no cancellation fees. You can open and close a SB on a commodity at any time during market hours.

Our Market Information sheets contain additional information on trading a SB on an underlying commodity. These can be found on the trading platform. For retail clients, a mandatory margin close-out rule is applied on an account level basis. This means that when the value of your account (i.e., the net profit and loss, any deposited margin and any other funds) falls below 50% of the initial margin requirement (that was paid to enter into all of the open CFD and/or spread bet positions at any point in time), one or more of your CFD and/or spread bet positions will be closed out. We may set a higher percentage than 50%. Retail clients who trade leveraged CFDs and spread bets have the benefit of negative account balance protection. Where this is the case, your liability will be limited to the funds in your account (which includes any funds that are not required to be maintained as margin to keep your positions open, regardless of whether those positions relate to this product).
